

## PUBLIC NOTICE

### BEDFORD BOROUGH COUNCIL PROPOSES TO INTRODUCE PARKING RESTRICTIONS ON MANTON LANE AND CLAPHAM ROAD, BEDFORD

---

**Reason for Proposal:** The proposals are aimed to improve road safety, the movement of traffic and address concerns of inconsiderate parking.

**Effect of Order:**

**1. To introduce ‘no waiting at any time (double yellow lines)’ restriction on the following lengths of roads:**

<b>A</b>	<b>Manton Lane</b>
(i)	On both sides of the road extending the full length between the roundabout joining Clapham Road to its junction with Brickhill Drive  <i>(Please note that the time limited parking within the layby outside Edith Cavell school will remain along with the school keep clear markings)</i>
<b>B</b>	<b>Clapham Road</b>
(i)	On both sides of the road extending the full length between its junction with Manton Lane and the roundabout joining Paula Radcliffe way  <i>(Please note that the bus stop on the southern kerb heading outbound of Bedford will remain whilst the bus stop on the north kerb heading inbound of Bedford will be removed)</i>

**2. To introduce a prohibition of verge and footway parking on the following length of road**

<b>A</b>	<b>Manton Lane</b>
(i)	On both sides of the road extending the full length between the roundabout joining Clapham Road to its junction with Brickhill Drive  <i>(Please note that the restriction will tie into the existing prohibition of verge and footway parking on Brickhill Drive to create a larger restricted zone. This will include Manton Industrial Estate (excluding any private roads))</i>

**BEDFORD BOROUGH COUNCIL (BEDFORD URBAN AREA (NORTH OF THE RIVER EXCLUDING QUEENS PARK AND CPZ AREAS)) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) ORDER 2009 (AMENDMENT NO.\*\*) ORDER 201\***

BEDFORD BOROUGH COUNCIL in exercise of the powers under Section 1(1), 2(1), to (3) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

Bedford Borough Council (Bedford Urban Area (North of the River excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall have effect subject to the following amendments:-

1. This Order shall come into operation on the \*\* 201\* and may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.\*\*) Order 201\*
2. As from the date upon which the Order comes into operation, the provisions of the "Bedford Borough Council (Bedford Urban Area (North of the River excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended" shall be varied as follows:
  - (i) The plan schedule reference "Grid Reference H22 Revision 0" shall be inserted
  - (ii) The plan schedule reference "Grid Reference H23 Revision 1" shall be deleted and the plan schedule reference "Grid Reference H23 Revision 2" shall be inserted
  - (iii) The plan schedule reference "Grid Reference I22 Revision 2" shall be deleted and the plan schedule reference "Grid Reference I22 Revision 3" shall be inserted
  - (iv) The plan schedule reference "Grid Reference I23 Revision 3" shall be deleted and the plan schedule reference "Grid Reference I23 Revision 4" shall be inserted
