PUBLIC PATH EXTINGUISHMENT ORDER 2020**

This Order is made by the Bedford Borough Council ("the Authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that the footpath described in paragraph 1 below is not needed for public use.

BY THIS ORDER:

1. The public right of way over the land situate between Maitland Street and Costin Street in Bedford Town and shown by a bold continuous centre line and a polygon outlined and hatched black between points A and B on the map attached to this Order and described in the Schedule to this Order shall be extinguished after 7 (seven) days from the date of confirmation of this Order.
2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along or across the said land as they had immediately before the date of confirmation of this Order.
3. This Order may be cited as the, "Bedford Borough Council (Bedford (Former Excluded Area): Public Right of Way on Foot between Maitland Street and Costin Street) Public Path Extinguishment Order 2020".

SCHEDULE

DESCRIPTION OF PATH OR WAY TO BE EXTINGUISHED

A Public Footpath in the former excluded area of Bedford Town commencing from a point where it has a junction with the eastern margin of publicly maintained road, Maitland Street, Bedford, between numbers 21 and 25 Maitland Street at Ordnance Survey Grid Reference (OSGR) TL 0464/4965 shown as Point A on the attached map then running in a generally east north-easterly direction for approximately 33 metres to the point where it has a junction with the western margin of publicly maintained road, Costin Street, Bedford, between numbers 20 and 24, Costin Street, Bedford at OSGR TL 0467/4967 shown as Point B on the attached map.

At the date of this Order the Definitive Statement records no information in respect of the width for the said Public Footpath in the former excluded area of Bedford Town. For the avoidance of doubt it is intended to stop up the entire extent of the Public Footpath described above and as shown on the Map attached to this Order.

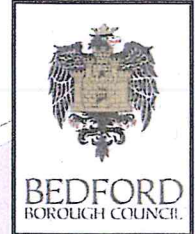
