**(AMENDMENT NO.4) ORDER 2020**

BEDFORD BOROUGH COUNCIL in exercise of the powers conferred under section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

- 1) The Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall have effect subject to the following amendment:-
  - (i) The plan schedule reference "Grid Reference P 19 Revision No: 1" shall be deleted and the plan schedule reference "Grid Reference P 19 Revision No: 2" shall be inserted.
- 2) This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009.
- 3) This Order shall come into force on the 15<sup>th</sup> day of June 2020 and may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.4) Order 2020".

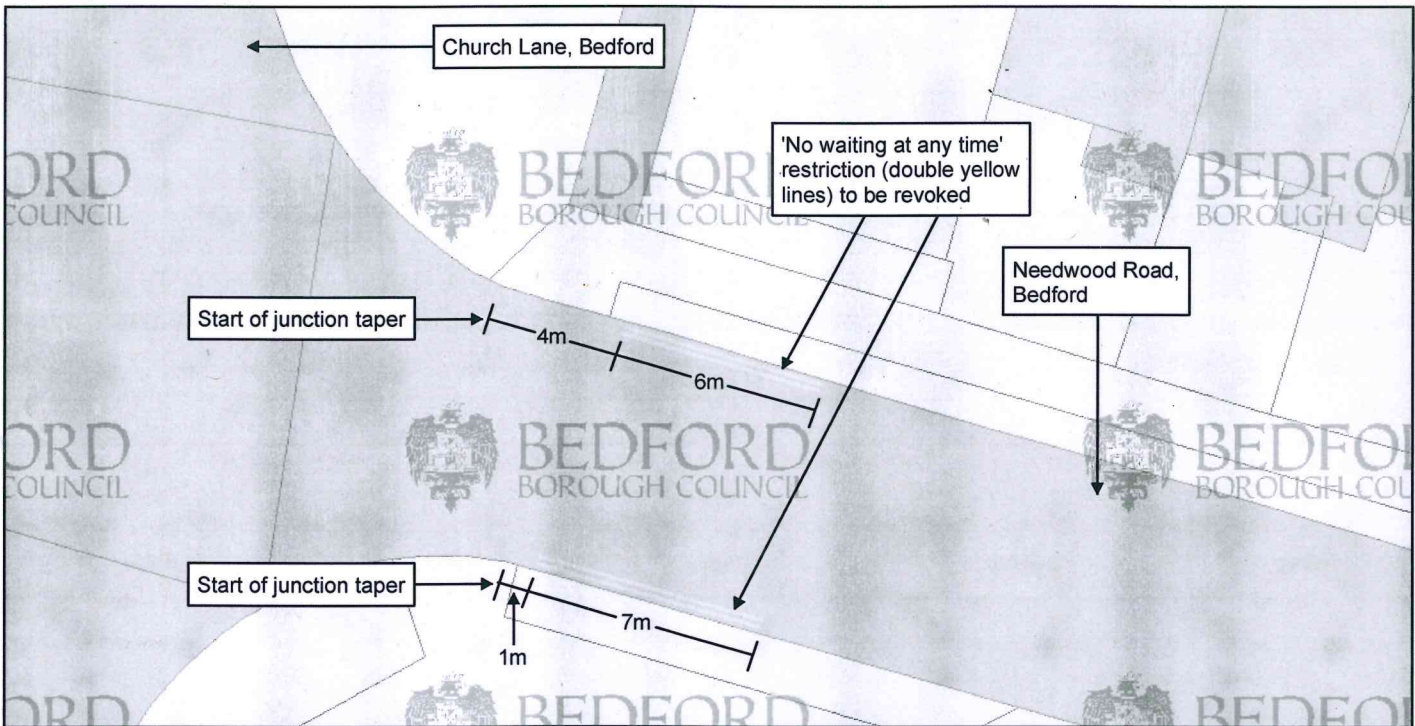

**STATEMENT OF REASONS**

Bedford Borough Council have introduced a pedestrian crossing on Needwood Road, Bedford, near to its northernmost junction with Church Lane. In order to facilitate the new crossing, it is necessary to revoke existing parking restrictions over the length of road the crossing will occupy. Parking on this length of road will subsequently be regulated by virtue of the fact that no parking is permitted on any length of a crossing including the associated zig-zag markings.

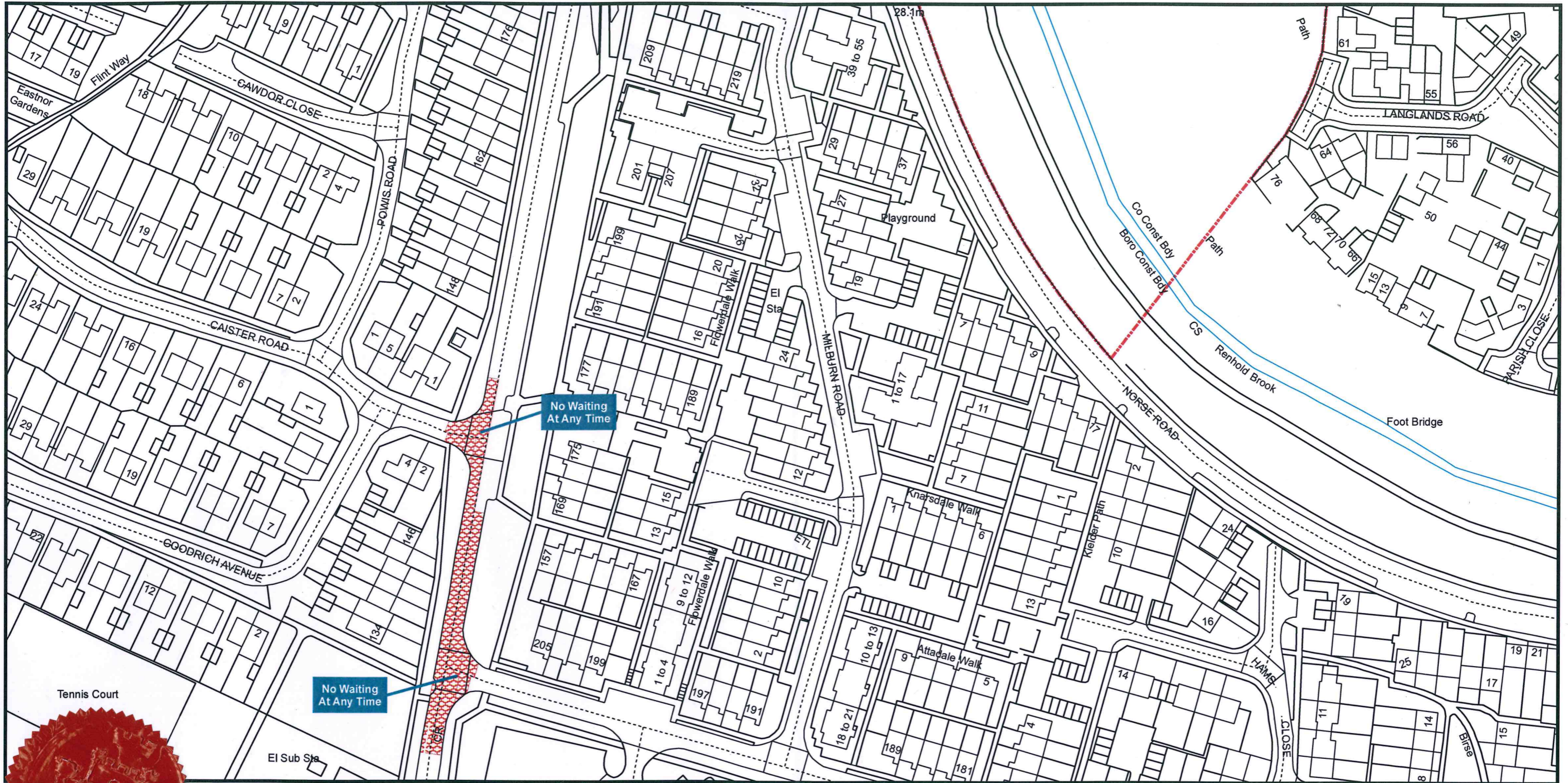
