BEDFORD BOROUGH COUNCIL (BEDFORD CONTROLLED PARKING ZONE) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) ORDER 2017 (AMENDMENT NO.6) ORDER 2019

BEDFORD BOROUGH COUNCIL in exercise of their powers under Section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1) This Order may be cited as the "Bedford Borough Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2017 (Amendment No.6) Order 2019" and shall come into force on 18th July 2019.
- 2) As from the date upon which this Order comes into force, the provisions of the "Bedford Borough Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2017 as amended" shall be varied as follows:

- (i) Add the following entry to **Schedule 3 – DISCRETIONARY PERMITS:**

Zone Y – List of streets where Zone Y permits are valid

Street
Ram Yard (the area south of the main carriageway which extends from a point approximately 53 metres west of Castle Lane to a point approximately 72 metres west of Castle Lane)

- (ii) Add the following entry to **Schedule 15 – Permit Charges:**

Permit Type	Charge
Zone Y Permit (all permits)	£750 per year

- (iii) The plan schedule reference "Grid Reference K 27 Revision No: 1" shall be deleted and the plan schedule reference "Grid Reference K 27 Revision No: 2" shall be inserted.
- 3) This Amendment shall be read and construed as one with the "Bedford Borough Council (Bedford Controlled Parking Zone) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2017".

STATEMENT OF REASONS

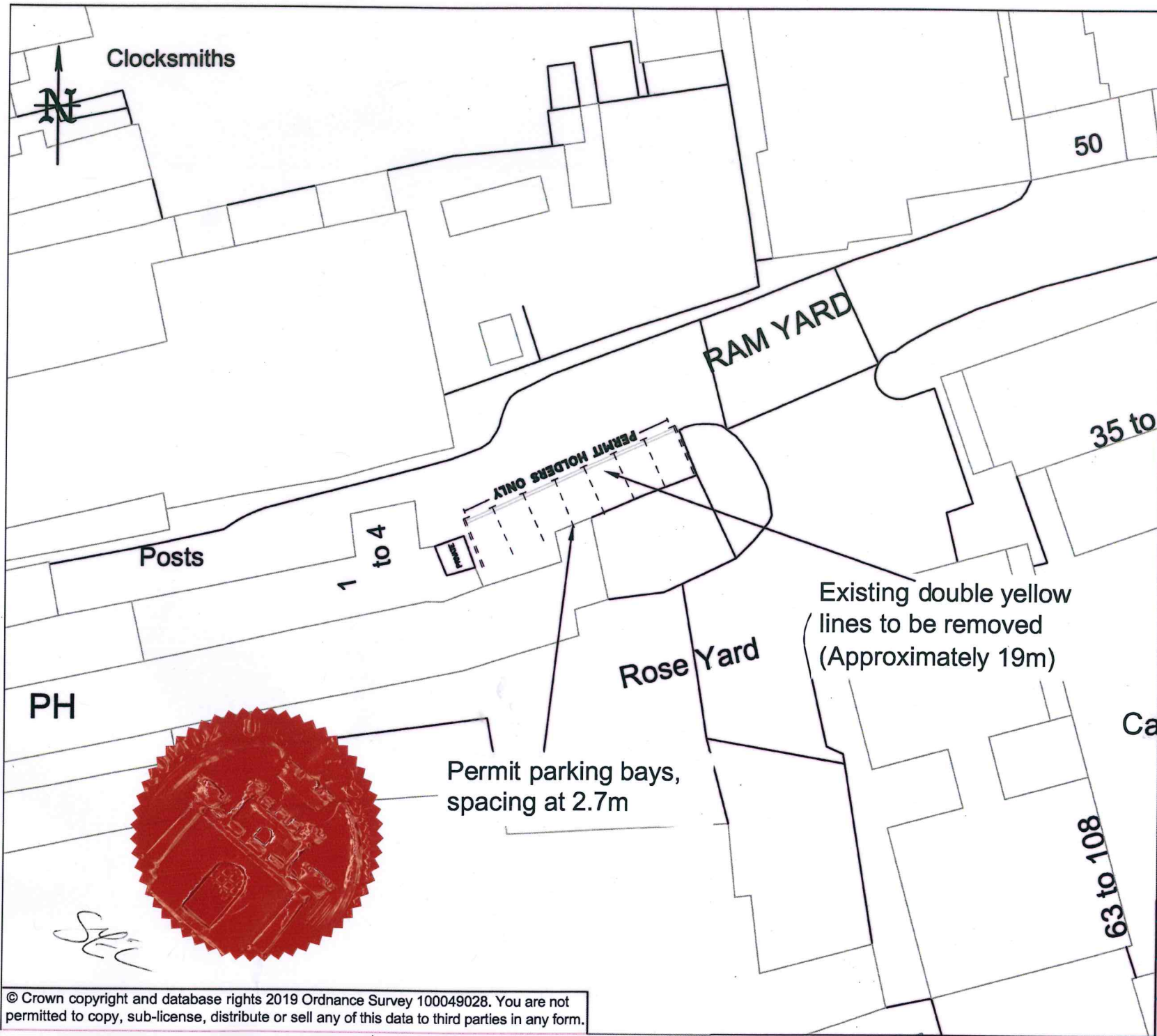
Bedford Borough Council wishes to enable local shops and businesses to make use of parking spaces on a currently unrestricted area of Ram Yard, Bedford.

To achieve this it is necessary to introduce a permit holders only parking restriction and to undertake parking enforcement.

Local shops and businesses will be able to apply for a parking permit in the newly created 'Zone Y' within the Bedford Controlled Parking Zone, and applications will be considered on a first come, first served basis.

The number of permits issued will be equal to the number of parking spaces created, and will be limited to one permit per shop/business.

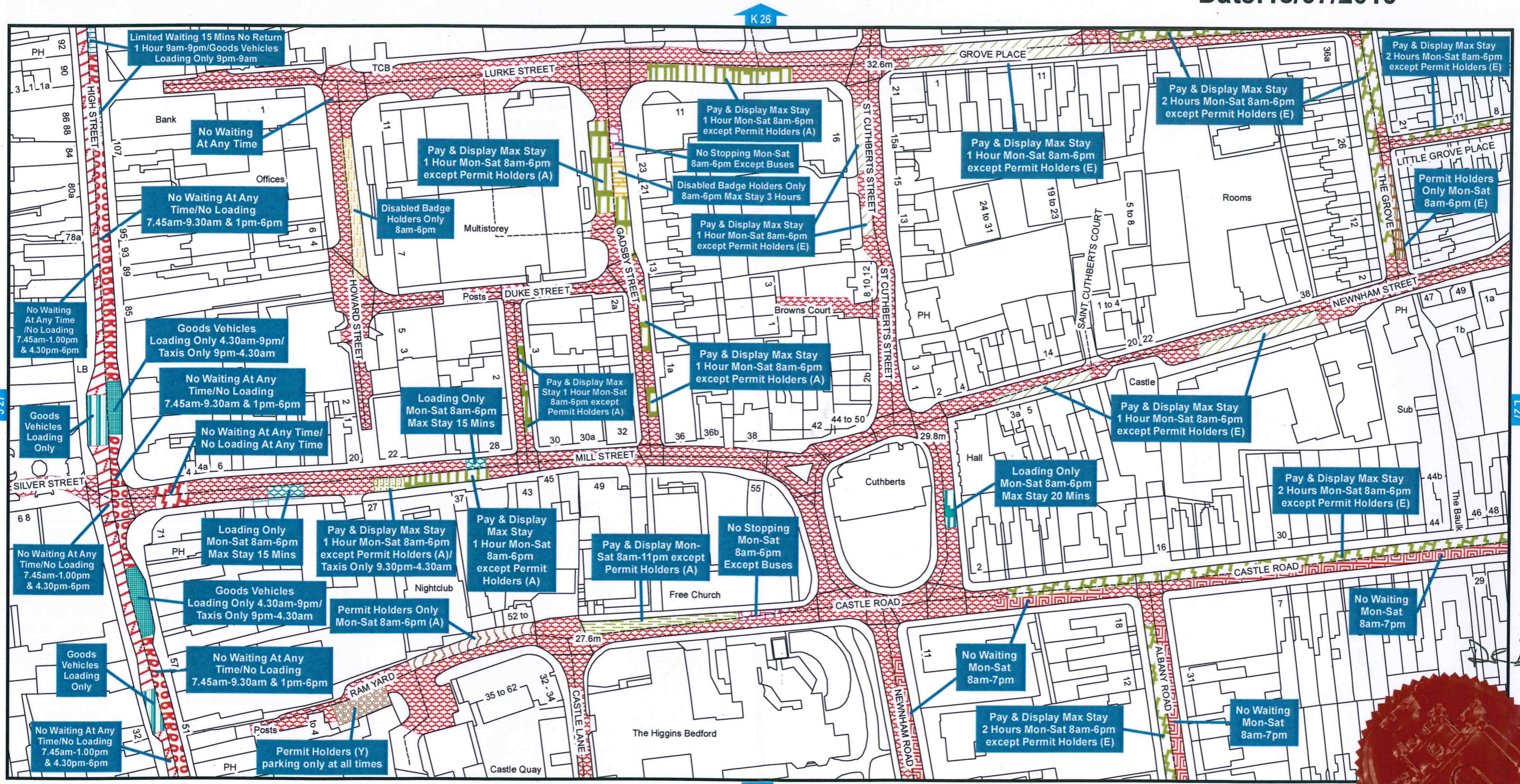
