**ORDER 2020**

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1) This Order may be cited as the "Bedford Borough Council (40mph Speed Limit) (Tithe Road, Kempston Rural) Order 2020" and shall come into force on 25<sup>th</sup> September 2020.
- 2) As from the date upon which this Order comes into force any previous speed limit Order made under the Act which relates to any length of road specified in the Schedule to this Order shall be revoked in whole or in part as appropriate.
- 3) No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on any length of road specified in the Schedule to this Order.
- 4) No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.

**STATEMENT OF REASONS**


Following a request from Kempston Rural Parish Council, Bedford Borough Council propose to reduce the speed limit from the national speed limit to 40mph on part of Tithe Road, Kempston Rural. This speed limit reduction is intended to help provide a safer road network for all highway users, including cyclists, pedestrians, horses and their riders.
